

TENTATIVE PARCEL MAP 06-04 AND VARIANCE 06-01

At a regular meeting of the Planning Commission of the City of Corcoran duly called and held on April 9th, 2007, on motion of Commissioner Garcia, seconded by Commissioner

REMOVAL OF REQUIREMENT FOR IRREVOCABLE OFFER OF DEDICATION

WHEREAS, Tentative Parcel Map 06-04, filed by Fred Figueroa was approved by Planning Commission on August 14, 2006; and

WHEREAS, the property is located on the northeast corner of Letts Avenue and North Avenue, APN 030-260-038; and

WHEREAS, the subject property is zoned R-1-6; and

Stiger, and duly carried, the following resolution was adopted:

WHEREAS, Condition No. 5 of Exhibit A, Resolution 06-14 stated "An irrevocable offer of dedication of 34 ft. is required for the Letts Avenue right of way and should be shown on the final parcel map"; and

WHEREAS, the City has determined that there will be adequate ingress and egress from Dairy Avenue and Orange Avenue because of a proposed subdivision on the southeast corner of Orange Avenue and Dairy Avenue; and

WHEREAS, it will no longer be necessary for the City to have the irrevocable offer of dedication; and

WHEREAS, the Planning Commission approved Variance 06-01 for this parcel on April 10, 2006, Resolution 06-03; and

WHEREAS, the Variance will lapse and become void on April 9, 2007; and

WHEREAS, the Planning Commission has carefully considered the staff report and recommendations on April 9th, 2007; and

WHEREAS, the Final Map must be corrected to show Parcel 1 to be a straight line of approximately 100 ft. wide and Parcel 2 to extend the westerly property line by 34 ft.

THEREFORE, BE IT RESOLVED as follows:

- A. That Condition No. 5 of Exhibit A, Resolution 06-14 requiring the 34 ft. irrevocable offer of dedication is hereby removed.
- B. That the Final Map must be corrected to show the width of Parcel 1 to be a

straight line of approximately 100 ft. and the depth will be 130.16 ft.

- C. Parcel 2 will have its westerly property line extended by 34 ft.
- D All other conditions and provisions of Resolution 06-14 for Parcel Map 06-04 remain in full force and effect.
- E. That any changes, other than those noted above, will require that the Tentative Parcel Map be resubmitted to Planning Commission.

Discussion:

As part of its efforts to improve the water system and to be in compliance with State mandates, the City is moving forward with a water meter project. The project will install new meters on all properties that are currently unmetered (flat rate) and will upgrade all existing meters on metered properties. This will be an extensive project carried out in phases and will eventually install/replace all residential and commercial meters in the community.

In order to finalize the agreement with the State Water Resources Control Board, the City is required to submit the attached resolution authorizing the installment agreement and appoint bond council. Staff is recommending the firm of Kutak Rock LLP which will allow the City to work with Albert Reyes as the bond attorney. The City has worked with Mr. Reyes previously when the water bonds and the redevelopment agency bonds were refinanced. In each instance, the City was extremely satisfied with the work quality and professionalism of Mr. Reyes.

Budget Impact:

As outlined in the agreement with the State Water Resources Control Board, the City will receive funding for the water meter project. Approximately 50% of the funding will be allocated as a bond and will be repaid by the City. Bond repayments will be paid from the water fund. The remaining 50% of the allocation for the meter project will be a grant to the City. The grant will not require repayment.

RESOLUTION NO. 3078

A RESOLUTION OF THE CITY OF CORCORAN AUTHORIZING THE EXECUTION AND DELIVERY BY THE CITY OF A CONSTRUCTION INSTALLMENT SALE AGREEMENT AND AUTHORIZING THE EXECUTION OF OTHER NECESSARY DOCUMENTS AND RELATED ACTIONS

WHEREAS, the City proposes to finance certain improvements to the City's water system, including the installation of water meters for the water system (the "2021 Project"); and

WHEREAS, to provide funds necessary to finance the 2021 Project, the City desires to enter into that certain Construction Installment Sale Agreement (the "Installment Sale Agreement") with the California State Water Resources Control Board (the "State Water Board") in the form presented to this meeting, with such changes, insertions and omissions as are made pursuant to this Resolution; and

WHEREAS, there have been presented at this meeting the form of Installment Sale Agreement relating to such action; and

WHEREAS, the City desires to appoint Kutak Rock LLP, as bond counsel ("Bond Counsel"), in connection with the financing of the 2021 Project; and

WHEREAS, all acts, conditions and things required by the Constitution and laws of the State of California to exist, to have happened and to have been performed precedent to and in connection with the consummation of the financing and refinancing authorized hereby do exist, have happened and have been performed in regular and due time, form and manner as required by law, and the City is now duly authorized and empowered, pursuant to each and every requirement of law, to consummate such financing for the purpose, in the manner and upon the terms herein provided.

NOW, THEREFORE, THE CITY COUNCIL OF THE CITY DOES HEREBY RESOLVE, DETERMINE AND ORDER:

Section 1. All of the recitals herein contained are true and correct and the City Council so finds.

Section 2. The form of Installment Sale Agreement submitted to this meeting and made a part hereof as though set forth herein is hereby approved. The Mayor, and such other member of the City Council as the Mayor may designate, the City Manager of the City, and such other officers

of the City as the City Manager of the City may designate (each, an "Authorized Officer") are, and each of them is, hereby authorized and directed, for and in the name of the City, to execute and deliver the Installment Sale Agreement in the form submitted to this meeting, with such changes insertions and omissions as the Authorized Officer executing the same may require or approve, with the advice and approval of the City Attorney and Bond Counsel, such requirement or approval to be conclusively evidenced by the execution and delivery of the Installment Sale Agreement by such Authorized Officer. In connection therewith, the City approves the execution and delivery of the Installment Sale Agreement so long as the maturity of the Payments (as defined in the Installment Sale Agreement) does not exceed [], 20[], the interest rate with respect to the Payments does not exceed \$[].
Section 3. The City Council hereby appoints the firm of Kutak Rock LLP, as bond counsel, in connection with the financing of the 2021 Project. The City Council hereby authorizes the City Manager to execute and deliver an agreement, if necessary, with said firm for its services Payment of fees and expenses with respect to such agreements shall be contingent upon the execution of the Installment Sale Agreement.
Section 4. The Authorized Officers and staff of the City are hereby authorized and directed, jointly and severally, to do any and all things, to execute and deliver any and all documents including but not limited to a fee agreement, costs of issuance agreement, custodian agreement or other similar agreements, which in consultation with the City Attorney and Bond Counsel, they may deem necessary or advisable in order to effectuate the purposes of this Resolution further including but not limited to, the execution and delivery of any documents required by the State Water Board ir order to complete the transactions contemplated by the Installment Sale Agreement, and any and all such actions previously taken by such Authorized Officers or staff members are hereby ratified and confirmed.
This Resolution shall take effect immediately upon its adoption.

Ladies and Gentlemen:

This firm serves as City Attorney to the City of Corcoran in connection with the Project. This opinion is delivered to the State Water Resources Control Board ("State Water Board") at the request of the City. In connection therewith, I have examined the laws pertaining to the City, originals of the Agreement, between the City and the State Water Board ("Agreement"), the City's authorizing resolution [xxxxxx] adopted on March 9, 2021, the City's reimbursement Resolution 2963 adopted on March 12, 2019, the City's rate-setting resolution 2866 adopted on September 27, 2016 (collectively, "the Resolutions"), the City's debt management policy, documents related to each of the Material Obligations as set forth in the Agreement, and such other documents, legal opinions, instruments and records, and have made such investigation of law, as I have considered necessary or appropriate for the purpose of this opinion.

Based on the foregoing, it is my opinion that:

- a. The City, a general law city of the State of California duly organized, validly existing under the laws of the State of California pursuant to the California Constitution, Article XI, Section 7, has the requisite legal right, power, and authority to execute and deliver the Agreement and carry out and consummate all transactions contemplated therein.
- b. The Resolutions have been duly adopted at meetings of the City which were called and held pursuant to law with all public notice required by law and at which a quorum was present and acting when the Resolutions were adopted. The Resolutions are in full force and effect and have not been amended, modified, supplemented, or rescinded, nor has the rate-setting resolution been challenged or the rates become subject of a referendum or initiative or other similar process.
- c. To the best of my knowledge and based upon a reasonable investigation, all proceedings required by law or under the ordinances or bylaws of the City to be taken by the City in connection with the authorization of the Agreement and the transactions contemplated by and related thereto, and all such approvals, authorizations, consents or other orders of or filings or

- registrations with such public boards or bodies, if any, as may be legally required to be obtained by the City prior to the date hereof with respect to all or any of such matters have been taken or obtained and are in full force and effect, except that no opinion is expressed as to any approvals, obligations or proceedings which may be required under any federal securities laws or state blue sky or securities laws.
- d. To the best of my knowledge and based upon a reasonable investigation, the execution and delivery of the Agreement and the consummation of the transactions therein will not conflict with or constitute a breach of or default (with due notice or the passage of time or both) under (i) the statutes creating the City or any amendments thereto, (ii) the ordinances or by laws of the City, (iii) any bond, debenture, note or other evidence of indebtedness, or any material contract, agreement or lease to which the City is a party or by which it or its properties are otherwise subject or bound or (iv) any applicable law or administrative regulation or any applicable court or administrative decree or order.
- e. To the best of my knowledge and based upon a reasonable investigation, the City has sufficient property rights in the Project property for the purposes contemplated in the Agreement and has complied with the requirements of the Uniform Relocation Assistance and Real Property Acquisition Policies Act of 1970 (42 U.S.C. 4601) with respect to any property acquired for the purposes of the Project. Project property rights extend/s in perpetuity/until [date].
- f. To the best of my knowledge and based upon a reasonable investigation, there is no action, suit, proceeding, inquiry or investigation before or by any court of federal, state, municipal or other governmental authority pending or threatened against or affecting the City's System, as defined in the Agreement, or the assets, properties or operations of the City relating to its System which, if determined adversely to the City or its interests would result in any material change in the assets or financial condition of the City, the City's System or the financial condition thereof, and the City is not in default with respect to any order or decree of any court or any order, regulation, or demand of any federal, state, municipal, or other governmental agency which default might have consequences that would materially and adversely affect the financial condition of the City or its System.
- g. No facts have come to my attention which lead me to believe that the City's authorized representative has made any untrue statement of a material fact or omitted or omits to state a material fact or has made misleading statements in the Agreement.
- h. The Agreement has been duly authorized, executed, and delivered, and assuming due authorization, execution and delivery of the Agreement by the State Water Board, constitutes legal, valid, and binding obligation of the City enforceable against the City in accordance with its terms, subject to the laws relating to bankruptcy, insolvency, reorganization, or creditors' rights generally and to the application of equitable principles, if equitable remedies are sought.
