#### **Recommendation:**

Approve first amendment to the lease agreement with K.W.P.H Enterprises (dba American Ambulance) for the administrative office space at 1031 Chittenden Avenue (APN 030-201-007) and authorize the Acting City Manager to sign said agreement.

#### **Discussion:**

American Ambulance has been leasing approximately 5,000sf of administrative office space of what was previously the Corcoran Police Department since March 10, 2020.

American Ambulance has agreed to extend the lease agreement for an additional five-year term and pay 40.5% of the PG&E metered bill.

#### **Budget Impact:**

The City's ability to rent the administrative office space to American Ambulance has resulted in revenues to the general fund.

#### FIRST AMENDMENT TO:

#### LEASE AGREEMENT BETWEEN

#### CITY OF CORCORAN AND AMERICAN AMBULANCE DATED MARCH 10, 2020

THIS FIRST AMENDMENT TO THE LEASE AGREEMENT WITH AMERICAN AMBULANCE is made and entered into as of all 1, 202 by and between the City of Corcoran (Landlord) and American Ambulance (Tenant). In consideration of the mutual agreements set forth below and in the Lease Agreement, the City and Tenant agree as follows:

- Recitals. This First Amendment is made with respect to the following facts and purposes, which the parties
  agree are true and correct:
  - a. On March 10, 2020 the City and American Ambulance entered into a Lease Agreement; and
  - b. Article III gave the option to extend the term of the lease for two five year terms by notifying the City at least 60 days prior to the expiration of the lease term of its intent to exercise the additional five year term.
  - c. Article V Rent and Expenses set forth the schedule of rent to be paid on or before the first day of each month. The option for first five year extension was:
    - i. January 1, 2021 through December 31, 2021 \$3,150 per month
    - ii. January 1, 2022 through December 31, 2022-\$3,200 per month
    - iii. January 1, 2023 through December 31, 2023-\$3,250 per month
    - iv. January 1, 2024 through December 31, 2024 \$3,300 per month
    - v. January 1, 2025 through December 31, 2025 \$3,350 per month

#### 2. Modifications.

Article V Rent and Expenses states, "At the end of the first term (March 1, 2020 through December 31, 2020) the Landlord and Tenant shall meet and confer in regards to the ongoing payment of the electricity.

The last paragraph of Article V is amended to read as follows with modifications in bold: In the event that any utility or service provider to the Leased Premises is not separately metered, Landlord shall pay for the amount due and separately invoice Tenant 40.5% of the PG&E metered bill for Tenant's pro rata share of the charges."

Other Provisions. Except as expressly provided herein, all other terms and provisions of the Agreement shall remain in full force and effect.

Presentation regarding CalPERS Pension Funding and the City Unfunded

Liability.

#### Discussion:

CalPERS is the City employees' retirement system. Employees make contributions to the retirement system by payroll deduction, and the City pays a percentage of the employees' earnings.

CalPERS investment losses due to the dot.com bubble burst in 2000 and the collapse of the housing market in 2008 wiped out tens of billions of dollars of value and put the CalPERS fund in a deep hole. The investment losses created what we refer to as "Unfunded liability" the gap between assets and what is needed to meet obligations to retirees.

CalPERS Hurdles & Considerations affecting the City contributions:



- 2019 Investment Experience Loss
- 2020 Investment Experience Loss
